Committee continues to review status of mental health services in La Crosse County.

Presentation by Jerri Hertel and Jenna Theler, both members of the CJMC.

They are "probation and parole agents", not social workers

Presentation titled "Mental Health Response from DOC Perspective"

8 regions in state-our region is 14 counties divided into 4 units with specialties like sex offender unit.

All people incarcerated and before they are released have a mental health eval and rated. This rating and multiple future ratings are kept in a database for use by staff. The rating determines who their agent will be, where they are placed, and what types of services and support will be given.

Certain mental health ratings qualify someone being released from prison for the "OARS" program(Opening Avenues to Reentry Success)-access to help with housing, meds, etc. BUT VOLUNTARY

Pointed out that most OARS participants are white people. Why?

Also a program for those not in prison called "OARS-2"

What are the gaps in services? ability to get involuntary commitments, big need for local providers, inflexible rules in treatment programs

Both women worked elsewhere in the system and say La Crosse is far above other areas in awareness and services. But we have no residential treatment options.

Program if someone has probation/parole revoked called "Wisconsin Resource Center"-it is part of Winnebago in Oshkosh. Nothing closer. Referenced as a "mental health prison". 5-6 month wait.

We need more mental health services, especially residential treatment programs both for mental health and substance abuse.

The committee is planning a retreat in person next month.
